## Definitions

'Carrier" means the party on whose behalf this Bill of Lading has been signed

"Merchant" includes the shipper, consignor, consignee, owner and receiver of the Goods and the holder

of this Bill of Lading.

"Goods" means the cargo described on the face of this Bill of Lading and includes any container not supplied by the Carrier.

2. Negotiability

(1) This Bill of Lading shall be deemed to be negotiable, unless marked "non-negotiable".

(2) By accepting this Bill of Lading, the Merchant and its transferees agree with the Carrier that, unless it is marked "non-negotiable", it shall be deemed to constitute the title to the Goods and the holder, by endorsement of this Bill of Lading, shall be entitled to receive or to transfer the Goods herein mentioned.

## Applicability

Notwithstanding the heading "Combined Transport Bill of Lading", the provisions set out and referred to in this Bill of Lading shall also apply when the transport is performed by one mode of transport.

### Law and Arbitration

4. Law and Arbitration
The contract evidenced by or contained in this Bill of Lading shall be governed by Japanese law. Any dispute arising from or in connection with this Bill of Lading shall be referred to arbitration in Tokyo by Tokyo Maritime Arbitration Commission (TOMAC) of The Japan Shipping Exchange, Inc. in accordance with the Rules of TOMAC and any amendments thereto, and the award given by the arbitrators shall be final and binding on both parties.

- Method and Route of Transportation

  The Carrier reserves to himself a reasonable liberty as to the means, route and procedure to be followed in the handling, storage and transportation of the Goods.

# Hindrances, etc. Affecting Performance

- Hindrances, etc. Affecting Performance
  If at any time the performance of the contract as evidenced by this Bill of Lading is or is likely to be
  affected by any hindrance, risk, delay, difficulty or disadvantage of whatsoever kind, the
  Carrier (whether or not the transport is commenced) may elect:

   (i) to treat the performance of this contract as terminated and place the Goods at the Merchant's
  disposal at any place which the Carrier deems safe and convenient, whereupon the responsibility

   (ii) to deliver the Goods at the place designated for delivery.

  transportation, and the Merchant shall pay any additional costs of carriage to and delivery and

  Withenever the Goods are found to be contraband or prohibited by any laws or regulations of the port of loading, discharge or call or any place or waters during the carriage the Carrier shall be entitled to have such Goods thrown overboard, discharged or otherwise disposed of at the Carrier's discretion without ompensation and the Merchant shall be liable for and indemnify the Carrier against loss of any kind, and any expenses arising out of such shipment.

The Carrier shall not be liable for any loss of or damage to or in connection with platinum, gold, silver, ewelfery, precious stones, precious metals, radioisotopes, precious chemicals, bullion, specie, currency, negotiable instruments, securities, writings, documents, pictures, embroideries, works of art, curios, heirlooms, collections of every nature or any other valuable goods whatsoever including goods having particular value only for the Merchant, unless the true nature and value of the Goods have been declared in writing by the Merchant before receipt of the Goods by the Carrier, and the same is inserted in this Bill of Lading and ad valorem freight has been prepaid thereon.

- Heavy Lift

  The weight of a single piece or package exceeding 1 metric ton gross must be declared by the Merchant in writing before receipt by the Carrier.

  In case of the Merchant's failure in the above declaration, the Carrier shall not be responsible for any loss of or damage to or in connection with the Goods, and at the same time the Merchant shall be liable for loss of or damage to any property or for personal injury arising as a result of the Merchant's said failure and shall indemnify the Carrier against loss or liability of any kind suffered or incurred by the Carrier as a result of such failure.

- Freight and Charges
  Freight and charges shall be deemed fully earned on receipt of the Goods by the Carrier and shall be paid in any event, whether the vessel and/or the Goods be lost or not, or the transport be broken up or frustrated or abandoned at any stage of the entire transit.

The Carrier shall have a lien on the Goods for any amount due under this Bill of Lading and for general average contributions to whomever due and for the cost of recovering the same, and may enforce such lien in any reasonable manner.
